Our commitments for 2025

Commitment 1 - Guarantee and promote business relationships based on the principles of impartiality, fairness, loyalty, good faith, and respect for people and the environment.

Target: 100% of framework contracts including a Sustainable Development clause by 2023.

Commitment 2 - Raise our teams' awareness of sustainable development issues and responsible purchasing.

Target: 100% of Purchasing and Supply Chain employees trained in responsible purchasing.

Commitment 3 - Control risks in the supply chain and embed CSR in all purchasing processes.

Target : 95% of our suppliers identified as being at risk assessed by a specialist third party.

Commitment 4 - Combine economic performance and sustainable development by favoring suppliers committed to sustainable development.

Target: 100% of national calls for tender take CSR into account - including the carbon footprint of the product or service purchased.

Commitment 5 - Make local purchases and favor the actors of the Social and Solidarity Economy (SSE).

Target: Setting up and managing local supplier panels by identifying and promoting companies from the SSE sector.

Commitment 6 - Engage with our suppliers to reduce greenhouse gas emissions.

Target: Implementation of a tool to monitor Scope 3 impact by the end of 2023 in order to enable the construction and implementation of 2025 performance plans.
